Overnight or certified mail must be sent with the "No Signature Required" waiver signed. Enry is timestamped when you submit online or your mailed entry is opened; not when payment is received. Entries received prior to 8:00 a.m. on April 7 will be returned.

**ENTRIES CLOSE ON Wednesday, April 23, 2025, at 6:00 p.m. Central Daylight Savings Time** after which time entries cannot be accepted, canceled, altered, or substituted except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows. Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry and shall be returned to the sender.

#### MOVE UPS

Move Ups between trials WILL be offered. All move-ups must be completed on an AKC entry form and turned in to the Trial Secretary by no later than 30 minutes before the trial begins.

# DOGS ELIBIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

**Condition of the Dog.** Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

No entries will be accepted by phone, fax, or hand delivery. Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Inquiries may be directed to Lana Neukirch, neulan0507@gmail.com. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

**Illegible entries** will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and will be returned to the exhibitor.

Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

#### WAIT LIST INFORMATION

Bexar County Kennel Club is not offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time.

# STAGING AREA AND WARM-UP INFORMATION

**Staging Area** will be out of view of search area(s). Staging area will include crating, warm-up, and waiting area, as well as the secretary table for check-ins and posting of running order and results.

The club shall designate a **warm-up area**. One labeled container per target odor being used in the trial on that day will be placed in the warm-area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well. Clubs may also place blank containers.

#### SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape, and of the size specified in the Regulations for each class.

**Search Area Conditions**. Searches may be indoors, on matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

**Search Area Sizes.** Search Area Sizes will be as required in the *Regulations for AKC Scent Work*. Areas of the outdoor site can be rocky, have uneven surfaces and narrow, steep stairs.

#### ADDITIONAL SITE INFORMATION

**Concessions.** A concession stand will be available both days. Proceeds benefit the Madison FFA Booster Club.

**Trial Site.** It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future.

**Possession of Odors and Training**. Chapter 5. Section 35 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

**Spectator Area.** Spectators are encouraged and this site is open to the public. Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run except in the case of Handler Discrimination classes. No one outside the search area may assist the handler or disclose the location of the hide. Spectators who intentionally or unintentionally give aid to a team may be asked to leave the area by the judge. Spectators are forbidden to discuss details of the search until the completion of the class.

**Crating.** Inside crating will be available. Crates may be left overnight; however, the Bexar County Kennel Club and Madison High School – AMP Campus will not be responsible for any lost or damaged items left at the show site.



**Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

# **RIBBONS, AWARDS, AND PRIZES**

Placement ribbons will be awarded in each class as follows:

First PlaceBlueSecond PlaceRedThird PlaceYellowFourth PlaceWhiteQualifying ScoreDark Green

A **New Title rosette** will be awarded to all dog and handler teams finishing a title.

An **engraved antique style magnifying glass** will be offered to all dogs and handlers finishing their Detective Title.

# High in Trial (HIT)

Only teams who participate in the same difficulty level in all elements offered (Container, Interior, Exterior, and Buried), and qualify in each are eligible to win High in Trial. The HIT award does not take into account Handler Discrimination classes, even if offered at the trial. The HIT is determined by adding the team's faults across the elements. The team with the fewest faults will be declared High in Trial. If there is a tie based on faults, then the team's times across the elements will be summed and the faster-finishing team will win. If there is a tie after considering both faults and time, a coin-flip will determine the High in Trial. There is hall be one High in Trial winner for each difficulty level offered.

#### High Combined Division (HCD)

Teams who participate in the same difficulty level in all elements offered (Container, Interior, Exterior, Buried, and Handler Discrimination), and qualify in each are eligible to win High Combined Division. The HCD is determined by adding the team's faults across all classes. The team with the fewest faults will be declared the winner of the High Combined Division. If there is a tie based on faults, then the team's times

across the classes will be summed and the faster-finishing team will win. If there is a tie after considering both faults and time, a coin-flip will determine the High Combined Division winner. There shall be one HCD winner for each difficulty level offered. The HCD award is not recorded by the AKC.

# NOTICE TO EXHIBITORS

## EXHIBITOR CHECK-IN

**Exhibitors MUST check-in EACH day they are entered.** Once the time and location for check-in is determined all exhibitors will be notified by email.

# SAFETY, BEHAVIOR, and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Bexar County Kennel Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Bexar County Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Bexar County Kennel Club or any official thereof.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local or state health requirements; for example, proof of rabies vaccination.

**Collars, Leashes and Harnesses.** During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

**All dogs must be on leash at all times,** and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

#### REFUNDS

**No entry fee** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical conditions are not eligible for a refund.

**Bitches in season** will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

#### RINGSIDE

**Judges are not required** to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public

address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

#### Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.


# DIRECTIONS TO THE TRIAL SITE

From the Northeast: Follow I-35 S to N 1604 Loop W. Take the exit toward Judson Rd. Turn left on Judson Rd. Drive 0.5 miles and turn right on Knollcreek. Drive 0.9 miles and turn left on O'Connor Rd. Drive 0.4 miles to the AMP entrance of Madison High School, on your left, just past the railroad tracks.

From the South: Head north on I-35 N. Exit N Weidner Road, turn left at the light. Continue on Crosswinds Way. Drive 2.7 miles to the AMP entrance of Madison High School on your left. The entrance is just before the railroad tracks.

From the Northwest: Take N 1604 E to the O'Connor Rd exit. Turn right on O'Connor. Drive 1.4 miles to AMP entrance of Madison High School, on your left, just past the railroad tracks.
